ORDER

As per the judgment read as 2nd paper above, the Hon.High Court has directed the Government to consider the application of Dawn International School, Velloorkkara, Puthencruz.P.O, Ernakulam for grant of NOC without insisting on compliance with Clauses (iv) and (xiv) of the guidelines and to pass appropriate order within the time limit, specified therein. In compliance with the judgment, Government vide G.O read as 3rd paper above have issued NOC to Dawn International School, Velloorkkara, Puthencruz.P.O, Ernakulam, for CBSE affiliation, subject to the rectification of the following defects notified in the proposal:

1. Students strength 93 only from Std I to VIII.

2. Possession Certificate, Location Certificate, Certificate from Bank, Health & Sanitation Certificate and Certificate from Local body in original required
3. List of UID and Photo ID of students not submitted
4. Certificate from local body proving the age of the school is not submitted.

2. The Director of General Education, Thiruvananthapuram, vide letter read as 5th paper above, furnished the rectified proposal of Dawn International School, Velloorkkara, Puthencruz.P.O, Ernakulam for the issuance of revised NOC. Besides, as per the judgment read as 6th paper above, the Hon.High Court directed the Secretary, being the 1st respondent to issue appropriate orders on the recommendations contained in Ext.P3, if necessary, after affording an opportunity of being heard to the petitioner, either physically or through video-conferencing and thus culminating in an appropriate order thereon, as expeditiously as is possible, but not later than two months from the date of receipt of a copy of the judgment. It is also ordered that once the aforesaid exercise is completed, and subject to the decision therein the DEO will complete all further processes with regard to the regularisation of the NOC of the petitioner's school without any avoidable delay thereafter.

3. Government have examined the proposal submitted by the Director of General Education, Thiruvananthapuram in detail and are pleased to issue revised NOC to Dawn International School, Velloorkkara, Puthencruz.P.O, Ernakulam, for CBSE affiliation, subject to the conditions mentioned in the Govt. Order read as 4th paper above.

4. The judgment read as 6th paper above is thus complied with.


